**Minutes and Matters Arising** 

The Minutes of the Parish Council Meeting held 7 July 2023 were approved and signed by the Chair as a true record. Proposed: Cllr Todd, Seconded: Cllr Sturgis elling of a tail, thin, single stein Silver Birch tree located o

The Action Register was discussed and updated.

Cllr Barker opted to look into the idea of improved village signage and to assess any repairs needed of other signs in the village.

Current parish mowing contract is due to expire on 31st October. Action: Cllr Harper to discuss with contractor.

### 3. CIL Projects and proposals were discussed

A member of the public proposed purchasing 5 bird and bat boxes, to be installed in the Jubilee Gardens arboretum in the Free Gardens, for a total of £281.90. This would need to be proposed to the GSCF by the Free Gardens Trustees who manage the Free Gardens; it was discussed that the environment in Great Somerford does provide habitat for bats, birds and owls and that in the past, Wiltshire Wildlife Trust put up boxes out of the way which didn't seem to be used. Action: Cllr Barker to speak to RSPB or Wiltshire Wildlife Trust for advice.

A local landowner has proposed using CIL monies to install 3 Kissing gates (2 near Rodbourne Brook GSMO25 and 1 at Whitakers Field), for a total of £1,382.40. Cllr Barker will walk the route and check the location of the gates and will speak with the landowner to clarify plans. If it is public right of way, it would be eligible for CIL funding. Regarding the project to set up a recreation area in the Glebe Field, which belongs to the Diocese of Bristol; Cllr Sturgis is still awaiting a written response from the Diocese' land agent and if this does not yield a result by October, approaches will be made directly to the Diocese .

## 4. Planning a) Planning

#### b) Housing developments

**Action:** Clir A Lennox to follow up with Ashford Homes about cutting the verge towards the Demainbray Close development, off Dauntsey Road.

Regarding Cotswold Homes development of 21 new houses just beyond Broadfield Farm - Liam Rinn is the Cotswold Homes contact and Cllr Sturgis will discuss concerns about access to the development site. The construction management plan says that the access will be through a field but it needs to be monitored. Ideally, the road adjoining the development should be only joined up at the very end of the development project. Cotswold Homes sent an email requesting that GSPC suggest new road names; It was noted that names of persons are not encouraged by Wiltshire Council. Some suggestions have been made which reflect the history of the location, such as Wallflower Lane, Barley Close, Canada Goose Lane. **Action:** Cllrs to put forward ideas to Cllr Griffiths to propose.

#### c) Neighbourhood plan

No updates this time as Cllr A Lennox absent. Cllr Sturgis noted that the Local Plan will be consulted on shortly and the review of the Neighbourhood Plan needs to be looked at. **Action:** Cllr Sturgis to assist Cllr A Lennox to incorporate the design statement and to show a positive plan. Cllr Sturgis does not believe that the Neighbourhood Plan will need much revision but will look at what Malmesbury Town Council has done.

#### 5. Finance Finance

# 6. Managed

Winkins Lane Playground

Facilities The wasp nest in Winkins Lane has been dealt with.

It was noted that the playground fence posts have become rotten. A new safety fence may be needed near the playground and could be eligible for CIL monies. Action: Cllr Vout

Community Room

PAT testing has been completed, the cleaner/caretaker carries out H&S checks and runs the taps every week to prevent salmonella risk. There are a number of actions on the Diocese of Bristol Acadamy Trust (DBAT) safety check-list for the building shared between Somerfords Walter Powell School and the GSPC Community Room which aren't relevant to the Community Room but the Parish Council has provided DBAT with information on the necessary checks being done. Action: Cllr Todd to respond to DBAT to confirm the Parish Council position and Health & Safety practices.

## 7. Environment To discuss:

a) Any actions for the Parish Steward or Council

Cllr Sturgis has written to Wiltshire Council about gullies and drains and has so far only received automated acknowledgments. An assessment has been made of drains in the village, and Cllr Sturgis will continue to raise awareness of those that require upgrading or repair. One of the main issues is the regular change of Wiltshire Council contractors and ensuing lack of ownership of the issues.

b) An update on Footpaths in the Parish

Some crops had not been cut away from public footpaths in the village, resulting in obstruction of public access, so Cllr Sturgis has spoken with the relevant landowners and will send a formal letter to request that it is done next year. Action: Cllr Sturgis; additionally to investigate who owns the footpath and gate on GSOM04, near Broadfield Farm, because the stile is difficult to get through.

### 8. Standing

**Items** 

To discuss any updates regarding:

Cemetery - Hedges have now been cut; Communications; Gt Somerford and Startley Defibrillators in Gt Somerford and Startley- the pads need to be replaced in March and May next year which will need to be recognised in the budget. Action: Cllr Todd to obtain costs and inform Cllr Harper; Book Exchange;

Emergency Plan; School's Liaison; Website – updates made in the summer;

War Memorial – grass needs re-turfing; Cllr Todd has approached a few companies. One local company has already quoted to re-turf and the costs are considered to be in the normal range at around £1,100 for ornamental grass. **Action:** Cllr Todd to provide evidence of three quotes/or evidence of attempts and checks on value for money. Cllrs approved in principle to do the work with further evidence to be provided by email in the meantime.
